# Annual Meeting report from March 9, 2010

The Annual Meeting was called to order by Sarah Berry, Town Clerk at 7:00 p.m. Dick LeCocq was nominated and elected as moderator.

The agenda, 2009 minutes and Board of Audit report were all approved.

Following discussion of the 2011 levy as recommended by the Town Board, motion was made and passed to set the levy at \$43,691 for General Fund, \$38,900 for Road & Bridge Fund, \$6,600 for Fire Fund and to establish a new Reserve Fund in the amount of \$5,000 for a

total levy of \$94,191.

In further business, the electors selected the Kanabec County Times as the legal newspaper for publication, Kanabec State Bank as the Township Depository, and to continue to use the Town Hall window as the official posting site.

Also on motion, it was decided to not make any donations to organizations for 2011.

The 2011 annual meeting date and time was set for the 2nd Tuesday in March at 7:00 p.m. at the Ford Town Hall.

## Treasurer term ending; web & newsletter editor needed by Edna Cole

I will be retiring from the Ford Town Board when my term as Treasurer expires January 2011. Thus, this will be my last issue of the Life & Times of Ford Township.

I volunteered for the newsletter although it clearly was not under the Treasurer's official duties. I have certainly enjoyed the experience,

first with then Supervisor Katie Kerr, and most recently with Van Hale Marketing. There never has been a lack of stories to tell and information to pass on.

The same holds true for the website. Our webmaster, Dave (The Web Guy) Zambory displayed extreme patience as we worked through the

content and design.

Township newsletters and websites such as ours are the exception rather than the rule but their importance was emphasized at the Comprehensive Plan group meetings as something they wanted to see continued.

## Von Bank resigns as town supervisor

Supervisor Ken Von Bank resigned from the Ford Town Board effective June 9, 2010.

Ken, one of the original members of the Ford Planning Commission, resigned from that group to accept the position of Supervisor on the Town Board in January, 2009.

The remaining members of the Town Board, Doug Bassett and Kim Johnson, together with the Town Clerk, Sarah Berry, can appoint someone to serve as Town Supervisor until the next general election which is in November. The appointee is eligible to run for the Supervisor 2 position which will be for the remaining two years of Von Bank's term or until the general election in 2012.

## Old Roads Vacated

At the March 2009 Annual Meeting, the electors voted to authorize the Town Board to proceed with vacating the old and unused roads within the Township. That process was completed in August 2009.

The next step was a road inventory which included an updated map and revision of the resolution which established the Ford Town Roads. In February 2010, the Town Board granted approval of the revision and authorized the recording of same.

Another resolution affirmed the designation of Kite Street as a private road.

## Four township officer elections during Nov. General Election!

In March of 2007, the electors voted to move the election of Township officers to occur in even years of the November General Election rather than at the March Annual Meeting.

This action also changed the term of officers for all members of the Board – Supervisors, Clerk and Treasurer – to four year terms. Previously Supervisors were elected to three year terms and Clerk and Treasurer were on a two year rotation. Thus because there are only three Supervisors on the Town Board, two cycle for election at one time and one the next time. Treasurer and Clerk alternate for election every two years.

Legislation has now been passed to permit townships to revert back to March elections once they had changed to November and/or also gives the electors the ability to shift township officers to six year terms thus eliminating the doubling up of expiring terms in any one election year. Action on either of these options would need to be taken by the electors at the Annual Meeting in March.

# Road closed signs, snowfence missing

When the Department of Natural Resources established a parking lot on Olympic Street for the public to access the Hunter Walking Trails in 2009, that lot also became a natural turn-around for the snowplows during the winter months. Thus the Ford Town Board passed a Resolution in November of that year to close the road north of that parking lot for vehicular travel for the winter months.

The road was properly barricaded with orange snowfence and signs announcing the road closing.

In April 2010, per Minnesota Statute 164.52, the Town Board rescinded the previous Resolution enabling the road to again be opened. However, when Road Supervisor Doug Bassett went to remove the signage and snowfence he found that all was gone.

The cost of the signage and snowfence was approximately \$300 and will need to be replaced before road closing again this winter.

If anyone has any information on this, they are asked to call the Kanabec County Sheriff's office at 679-8400. The missing items could also be returned to the Ford Town Hall – no questions asked.

## Tall Buttercup weed prevalent in Ford

This year the Ford Town weed inspection was completed by Supervisor, Doug Bassett, and Kanabec County Environmental Services Director, Teresa Bearce, on June 4.

Once again Tall Buttercup was noted in a lot of hayfields and pasture lands.

Since this noxious weed regenerates from seed, landowners need to cut it down before the plant matures and goes to seed. Mowing it down early in fields and pastures is the best way to control Tall Buttercup.



Landowners who rent their hayland should make sure that the person cutting it has clean equipment to help prevent further spread of the Tall Buttercup seed.

# Grant monies available from the SRWMB

The Snake River Watershed Management Board (SRWMB) is a four county non-regulatory joint powers organization, which was established in May 1993 pursuant to Minnesota Statutes section 471.59. The board was created in response to increasing water problems and recreational and development pressures occurring in the Snake River Watershed.

A watershed is an area of land where water from rain and melting snow drains downhill into a body of water. Thus the Snake River Watershed is not just the Snake River but encompasses all the land, wetlands, lakes, streams and rivers that convey that water. The entire Township of Ford is included in the Snake River Watershed.

Incentives are in place for cost-share programs to protect the Watershed. Thanks to a Minnesota Pollution Control Agency grant, now in 2010 money is available for individuals, groups, Cities and

Townships. Most of these projects can be funded up to 75% of the total cost and many could have 90% covered.

Another grant application is also being considered to repair the damage ATVs have created along the Snake River on Olympic at the bridge. This would include the installation of posts discouraging ATV entrance into the River.

There also is a low interest loan program for resident homeowners with a failing septic system. ## Annual Town Road Review Completed

The Town Board completed the annual review of all of the Town Roads on Saturday, May 29. Roads were found to be in good condition.

The gravel that was spread in 2009 really made a big improvement to the general condition of the roads.

The brushing project that had been planned but then postponed

because of budget constraints was finally completed in April of this year. This process opened the roads for safety issues and air movement.

Gravel scheduled for delivery on 330th, 340th and 360th Avenues was completed and spread in June.

The washout on Olympic Street will be addressed soon.
